

**JEWELSPRIDE CATTERY  
BENGAL KITTEN DEPOSIT AGREEMENT**

We honour our waiting list, so we operate on a first deposit, first choice basis. We accept electronic money transfer, money order, personal cheque or cash for the deposit, and kittens must be paid for in full by ten weeks of age before they are released to their new homes, as per the terms set out in this agreement.

The terms of this deposit agreement are as follows. Please initial beside each statement and fill out the bottom portion completely.

By submitting my deposit and this completed form to Jewelspride Cattery, I confirm the following:

\_\_\_\_ I understand that my initial deposit (\$250 pet/\$500 breeder) is non-refundable (the "Initial Deposit"). I understand that this policy is in place to ensure that I am fully committed to purchasing a kitten.

\_\_\_\_ I have received prior approval from my landlord, roommates, or any other person who may potentially disallow a bengal kitten/cat to live in my home.

\_\_\_\_ I understand that if a kitten is not offered to me within one year of my Initial Deposit, my Initial Deposit may be refunded ONLY if I have not refused other available kittens within that year. If I have refused available kittens within the year, my deposit will not expire OR be returned to me. Instead, I may elect to forfeit my deposit or continue waiting on a kitten of my choice and will retain my place on Jewelspride Cattery's waiting list.

\_\_\_\_ I understand that although Jewelspride will make reasonable efforts to contact me individually via email regarding available kittens, it is my responsibility to regularly view Jewelspride's website and Facebook page to view available kittens and cats. By labelling a kitten as "Available to the Waitlist" or "On Hold for the Waitlist" in an email, on the website, or on its Facebook page, Jewelspride is thereby *offering* the kitten to me. It is ultimately my responsibility to contact Jewelspride to enquire about any kitten displayed in any of these manners if I am interested in it and have not been contacted directly.

\_\_\_\_ I understand that when I have chosen a kitten and that kitten reaches six weeks of age a second non-refundable payment of (\$800 pet/\$2000 breeder) is due (the "Second Installment"). At this time the kitten will be evaluated by Jewelspride Cattery and I will be notified of the final price of the kitten and given the final purchase contract for review and signature. The balance of the amount due for the kitten will be given to Jewelspride Cattery along with the signed final purchase contract by no later than the time the kitten is ten weeks old.

\_\_\_\_ I understand that if I neglect to adhere to the payment deadline for the Second Installment I will forfeit my Initial Deposit unless I have made *prior* arrangements with Jewelspride Cattery to continue to wait for a different kitten.

\_\_\_\_ I understand that if I neglect to adhere to the Final Payment deadline I will forfeit my Second Installment unless I have made *prior* arrangements with Jewelspride Cattery to continue to wait for a different kitten.

\_\_\_\_ I understand that if I am having the kitten shipped to me, the kitten must be paid for in full, and this deposit form along with a completed and signed final kitten contract must be returned to Jewelspride Cattery before shipping is booked.

\_\_\_\_ I understand that as the Purchaser, I am responsible for all shipping costs if applicable, including health certificate/veterinary exam, rabies vaccine, and airfare. An airline approved shipping crate is provided at no cost in lieu of kitten care package

\_\_\_\_ I understand that the kitten made available to me is at the discretion of the breeder. A similar kitten may be substituted if the desired kitten becomes unavailable or is being kept for a breeding program.

\_\_\_\_\_ I understand that this kitten is being sold with/without breeder rights (indicate one).
